# Executive Director's Report 2022

At the heart of JBI's vision and mission is a fundamental desire to build a brighter future for generations to come, and in 2022 our team remained unwavering in its commitment to reach this goal.

Over the last 12 months, we consolidated our restructure giving each division a clear remit across our synthesis, transfer and implementation programs. This year, we continued to execute our strategy to advance our organisation as a hub of innovation through research and commercialisation.

We engaged a business development manager to identify new opportunities to extend our reach and diversify our revenue streams. This included a comprehensive review of our programs and products and the development of a local, national and international stakeholder engagement strategy that spans the government, clinical and commercial sectors. This has provided valuable insights into priorities and how JBI resources align with external stakeholder goals.

Event highlights included our third World Evidence-Based Healthcare Day campaign with the theme of 'Partnerships for Purpose'. There was incredible engagement with the campaign from across the globe, which highlighted both challenges and facilitators of the creation of equitable partnerships across the evidence ecosystem. We also hosted our annual JBI gLocal Solution Room, which speaks directly to the pragmatism of JBI and our commitment to support those we seek to serve, who are working at the coalface caring for patients.

JBI's global collaborative evidence network, the JBI Collaboration (JBIC), has continued to contribute to our vision and mission this year. In 2022, following a brief suspension of new applications, we welcomed three new entities from Australia, Hong Kong and the USA. We were excited to see the return of face-to-face training and continued efforts across the synthesis and implementation programs globally.

While the University of Adelaide achieved a positive result in 2021, forecasts for 2022 and beyond were predicted to be much more challenging. There is still considerable uncertainty around international markets, and the fall in enrolments and commencements the University has experienced will have an impact over the coming years. It is within this context that the University sought to ensure its surplus was reserved to help support its education and research efforts over the next few challenging years, and this includes careful oversight of the JBI budget.

Although our royalty revenue from our commercial partner declined marginally and our block grant funding was reduced, we remain in a stable position and are taking steps to mitigate risks to ensure our continued viability and sustainability.

Ultimately, it is our people who make these achievements possible. Our people in Adelaide (to whom I will be forever indebted for the reward that is working with such inspired individuals), the people we collaborate with as part of our own global collaborative evidence network (the expert researchers and clinicians across the JBIC) and the people we work in partnership with from other leading global evidence-based organisations (including but not limited to Cochrane, the Campbell Collaboration, GIN, NICE and others).

Our collective desire to achieve the brightest future starts with the collective wisdom of the brightest minds to help achieve our vision and mission. Thank you seems too small a word to reflect my deep gratitude for the contributions of all those mentioned above.

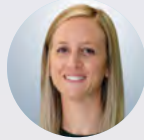

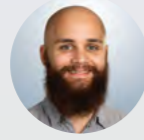

# Strategic Plan 2020–2024

## JBI New Horizons:

### Bigger, Better, Brighter

JBI's strategic plan aims to ensure we generate impact by informing policy and practice and the global discourse as it relates to evidence-based healthcare (**Impact Horizon**); to develop a robust strategy for continuous quality improvement of products, processes and services across all programs (**Quality Horizon**); and to build a sustainable business strategy that prioritises the long-term survival of JBI and enhances our capacity to endure and remain relevant to key stakeholders (**Viability Horizon**).

Below is an overview of the ways in which we have been working towards our strategic plan in 2022.

#### Priority 1: Engagement and Exchange (stakeholder communication)

- The inaugural JBI Collaboration Brighter Futures Grant Program opened in August 2022, funding activities and projects undertaken by JBI Affiliated Groups and JBI Centres of Excellence. These entities further JBI's mission of promoting and supporting evidence-based healthcare globally, with a view to fostering collaboration within and across the network and with external stakeholders; building capacity for JBIC Entities in low- and middle-income countries; and supporting multilingual projects and activities.
- The JBI EBP Database Field Collaborator's Program was launched, whereby members engage and collaborate with international experts within their selected field to develop evidence-based resources for health professionals, utilised in 60+ countries.
- JBI implemented a robust digital media and online event strategy to continue to engage with both current and new key stakeholders across the world. This included the JBI gLocal Solution Room, held for the second time in 2022 and attended by 30,000 people. This initiative was a week-long series of free, local events held in 17 countries, helping health professionals get research into practice.
- For the third year, JBI led World Evidence-based Healthcare Day in consortium with six other leading global organisations in EBHC. In 2022, this global initiative reached 43.4 million people in 123 countries.
- The JBI Evidence Implementation Network was launched to help reduce the gap between research and clinical practice through training, innovative research, development of tools and resources, and collaboration and engagement with decision-makers.

#### Priority 2: Evidence and Empirics (scholarship and research)

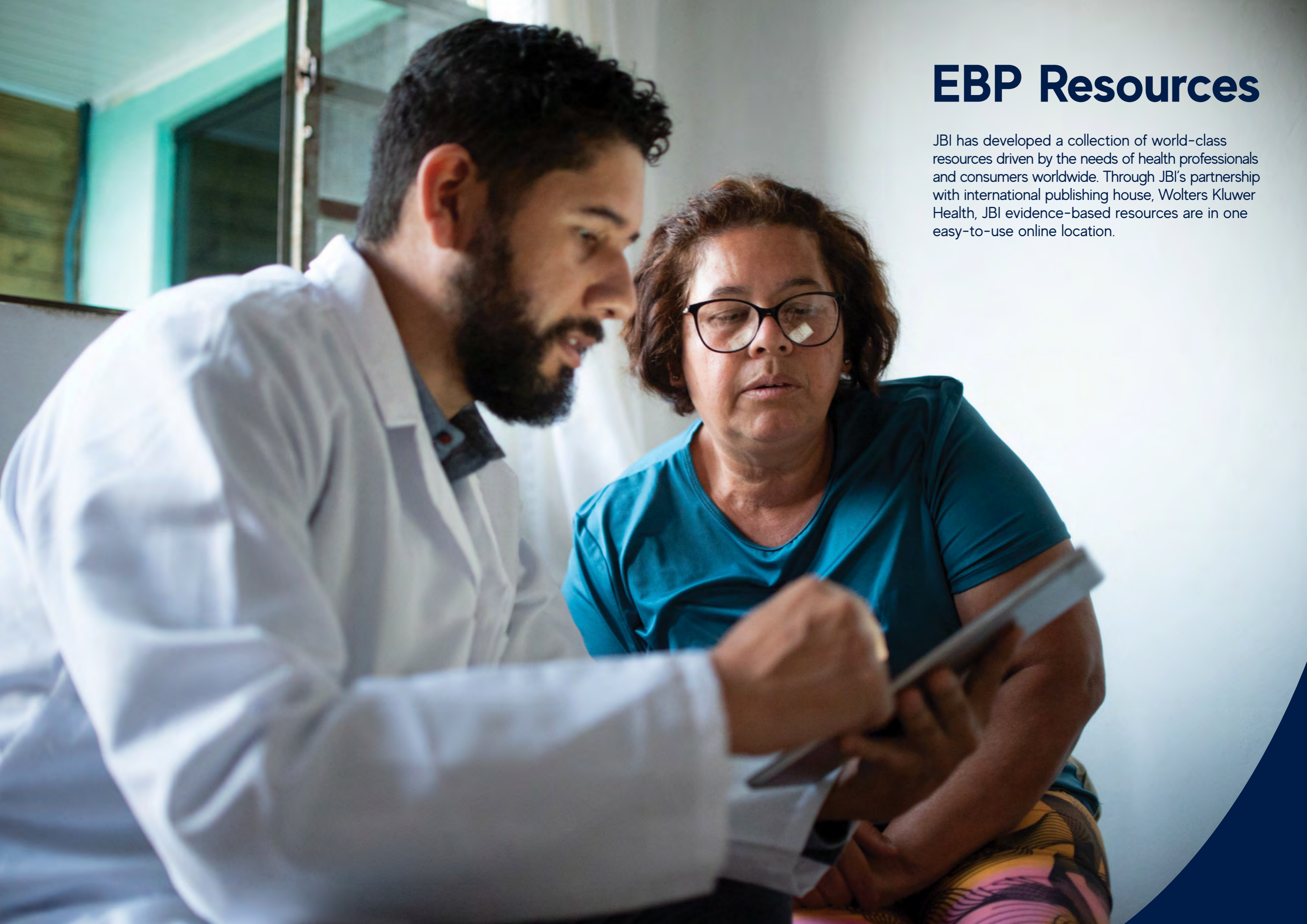
- The JBI Evidence Synthesis Taxonomy Initiative was launched, funded by an NHMRC Investigator Grant. The primary objective of this project is to develop a comprehensive evidence synthesis taxonomy to encourage and facilitate appropriate research synthesis to inform policy and practice.
- *The Journal of Clinical Epidemiology* published a JBI Series in October 2022, comprising four papers on JBI's approach to evidence-based healthcare, including synthesis, implementation and its global collaborative evidence network.
- JBI's commitment to scientific development also continues via its Methodology Groups, comprising experts from across JBI and the JBI Collaboration to examine its methodologies for synthesis, transfer and implementation. Highlights from 2022 included the establishment of the Evidence-based Point-of-Care Methodology Group, the publication of the JBI position statement for rapid reviews and the inaugural JBI Methodology Month held in April 2022.
- *JBI Evidence Synthesis* published a methodology-themed issue featuring some of the latest developments in methodology from JBI and the JBI methodology groups, and created a Methodology special collection, available via the eJP.

#### Priority 3: Evaluation and Excellence (continuous quality improvement)

- JBI has taken great strides this year towards ensuring that our resources are always of the highest quality. All EBP products are reviewed and updated annually, and development plans have been put in place to expand and enhance content and features. This work is informed by stakeholder engagement initiatives and market research, conducted both in collaboration with and independently of our commercial partners.
- A comprehensive review of the JBI EBP Database's specialty fields was undertaken, leading to the establishment of 12 new specialty fields.
- A new format for Best Practice Information Sheets was introduced in 2022, which includes a visual summary that creatively captures and communicates the findings from a published JBI systematic review through infographics.

#### Priority 4: Evolution and Expansion (innovation for the future)

- JBI appointed a Business Development Manager, Ms Lisa Hunt, to facilitate JBI's strategic growth through global research commercialisation and Category 1 grant funding opportunities in Australia.
- JBI re-opened applications to join the JBI Collaboration and welcomed three new partners from Charles Darwin University, Darwin, Australia; Hong Kong Polytechnic University, Hong Kong; and Loma Linda University Health, Loma Linda, USA.
- In 2022, JBI formally launched the brand new version of its clinical audit and quality improvement software, JBI PACES. We also released numerous significant updates for our systematic review software, JBI SUMARI, including title, abstract and full-text screening.
- JBI entered into an agreement with CEBAM Digital Library Health and EBMPacticeNet to translate the JBI EBP Database (Evidence Summaries, Recommended Practices, Best Practice Information Sheets) into French and Dutch, and disseminate the information to the citizens of Belgium.
- *The JBI Evidence Implementation* journal launched six new special collections, including Cancer Care, Diet and Nutrition, Pain and Rehabilitation, ICU Nursing, Women's and Children's Health and Editor's Choice.
- The number of JBIC Entities offering the JBI Evidence Implementation Training Program more than doubled in 2022, contributing to a 236% increase in total registrations.

A pilot campaign to communicate the strengths, value proposition and uniqueness of the JBI EBP Database and the Women’s and Children’s Health Field was implemented in 2022.

The one-month campaign resulted in **740 free-access resource downloads** (Evidence Summary, Recommended Practice, Best Practice Information Sheet).

Following the campaign’s success, similar campaigns for specialty fields will be implemented in 2023.

JBI Evidence Synthesis is the premier periodical for diverse systematic reviews that move beyond effectiveness. All selected systematic reviews, scoping reviews and all protocols apply JBI methodology and methods.

Six Best Practice Information Sheets were published to complement selected systematic reviews.

## Special methodology issue

Issue 4 in 2022 was a methodology-themed issue featuring some of the latest developments in methodology from JBI and JBI methodology groups.

A number of the papers were accompanied by video abstracts from the authors. Videos included discussion by authors of the methodology paper, 'Best practice guidance and reporting items for the development of scoping review protocols', which had more than 1,200 views.

A digital media campaign highlighting the strengths and uniqueness of JBI methodology was introduced in 2022. The special methodology issue of *JBI Evidence Synthesis* was a key driver of the campaign.



## Editorials in motion

Video editorials highlight the takeaway points of the commentaries and discussion pieces displayed over impactful imagery, and offer a new way for readers to engage with our content.

Ten 'editorials in motion' were published in 2022. These received 1,400 views, compared with 562 views for the seven 'editorials in motion' published in 2021.



## Submissions

The journal received submissions from 44 countries in 2022; a slight increase from 42 countries in 2021. Overall, there was a 4.7% decrease in submissions from 2021 to 2022, with a total of 474 submissions. The acceptance rate in 2022 was 32.7%

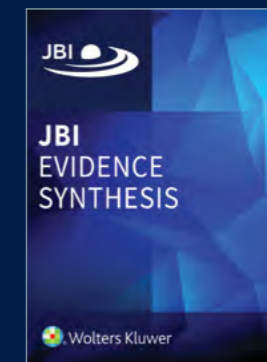

In 2022, the JBI Evidence Implementation Network was launched. The purpose of the website is to link the international health community with JBI's implementation resources, training programs and advice on opportunities to contribute to the development of innovative clinical research and the dissemination of best practice evidence at the point of care.

At the close of 2022, the network, @JBI\_EI, had 10.1k followers on Twitter, an increase of 3,100 (44%) from the previous year.

Four issues of the JBI Evidence Implementation Bulletin were published in 2022 to coincide with the quarterly release of the journal. This journal supplement promotes implementation projects featured in the journal as well as the latest resources and events. It also features submissions from across the network, including opinion and commentary articles as well as examples of practice evaluation and improvement.

Launched in 2021 with 117 subscribers, the JBI\_EI Bulletin had 2,591 subscribers by the end of 2022, an increase of 2,474 (2,114%).

## JBISUMARI

JBI SUMARI is an online software tool designed to provide end-to-end support for authors conducting systematic reviews and scoping reviews, including protocol development, title, abstract and full-text screening, critical appraisal, data extraction, synthesis and preparing the review report—all within the one online software program. JBI's easy-to-use critical appraisal tools are embedded in JBI SUMARI for multiple and diverse review types, making it easier to conduct rigorous and robust reviews.

- Access to JBI SUMARI for all users is now via a single sign-on system
- The JBI SUMARI website was revised and a new 'Product Updates' section was introduced

### Major updates released

More streamlined and customisable title and abstract screening and full-text screening so that users can:

- have different rules/set-up for title and abstract screening and full-text screening
- allocate specific review team members to manage conflicts
- be confident in the knowledge that no screening data, appraisals or extracts will be lost if screening rules are changed, unless the study is deleted from the project.



### Minor updates released

- New 'hide abstract' feature in screening phases
- Records in screening phases now ordered in the same way (alphabetical order) for all participants
- Addition of a 'My Decisions' tab in screening phases
- Ability for project owner and privileged author to revert team decisions during screening
- Exported records in screening are now at project level
- All text boxes have increased character limits (particularly useful in qualitative synthesis phase, which may contain large findings/illustrations)
- Text boxes are now scalable and do not lose focus to avoid data not saving

The JBI SUMARI Knowledge Base was updated to reflect the changes listed above, including additional tutorials.

### Future initiatives

Work has already commenced on updating how citations/records are imported and managed within JBI SUMARI. This will allow users to seamlessly import large amounts of citations across multiple formats within the system as well as to manage their 'library' of records, delete records that have been imported and auto-remove duplicate records prior to screening.

## JBI PACES

JBI PACES (Practical Application of Clinical Evidence System) is intuitive software that assists healthcare professionals to conduct efficient clinical audits in their local setting. JBI PACES has been developed by clinicians, for clinicians, to improve the quality and safety of healthcare and patient outcomes. JBI PACES embeds JBI's gold standard 'Getting Research into Practice' approach—a guided process for teams to work through change management.

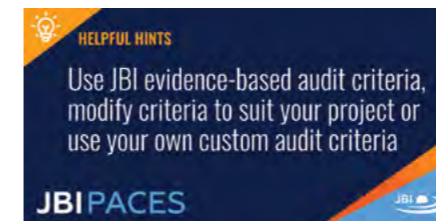
### Highlights

- In August 2022, JBI officially launched a revised and improved version of JBI PACES
- A new website was developed and released. A survey of users was conducted in 2022. Results identified further development priorities and revealed the top areas of practical use from further development, which have informed ongoing improvements and updates to the software.

### Major updates released

Several new features and enhancements were introduced in 2022, including:

- User ability to export data into CSV format or Microsoft Excel to allow detailed statistical analyses and to create charts.
- User ability to collect numerical data (i.e. continuous or discrete data) for evaluation of different outcomes. Examples include blood sugar level, length of patient stay in hospital, number of falls episode and quality of life score.

JBIC's global Collaborative Evidence Network, the JBIC Collaboration (JBIC), spans 80+ universities, hospitals, health facilities and NGOs in 38 countries who each lead evidence-based initiatives in their community or region, directed by the knowledge needs of local clinicians and consumers.

The JBIC consists of JBIC Centres of Excellence and Affiliated Groups that are driven by a unified purpose to contribute to improvements in the quality and outcomes of healthcare globally through the delivery of high-quality programs of evidence synthesis, transfer and implementation.

The JBIC harnesses the diverse strength of its members to benefit and connect colleagues in new and innovative ways, empowering them to work together, communicate and share knowledge, while leveraging existing resources to tackle large and complex problems in healthcare globally using JBIC's approach to evidence-based healthcare.

For members of the JBIC, 2022 continued to be a challenging year, with many colleagues continuing to focus their efforts on addressing the challenges of the COVID-19 pandemic, including the development and implementation of evidence-based methods, strategies and approaches to COVID-19.

Many JBIC activities, however, began to resume. In particular, the delivery of JBIC short courses by both remote (online) and face-to-face delivery. As a global Collaborative Evidence Network, the JBIC maintained its strength and its willingness to share and collaborate with colleagues from around the world in the promotion and support of evidence-based healthcare.

The 68th JBIC Meeting was held virtually (for the third time) in November, where we met with 187 JBIC directors, convenors, deputies and staff across three days and five regions to plan the way forward for 2023.

Given the exponential growth of the JBIC over the past five years, and the new systems required to support partners by solely remote means, we paused applications to join the JBIC until July 2022.

We were pleased to welcome three new Affiliated Groups to the JBIC in the second half of 2022: from Charles Darwin University, Darwin, Australia; Hong Kong Polytechnic University, Hong Kong; and Loma Linda University Health, Loma Linda, USA. We are proud to acknowledge 42 Centres of Excellence and 38 Affiliated Groups as a part of the global JBIC family.

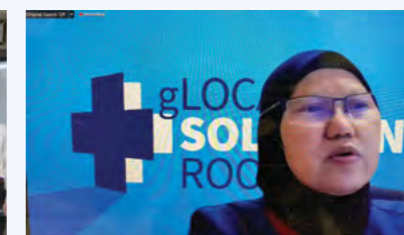
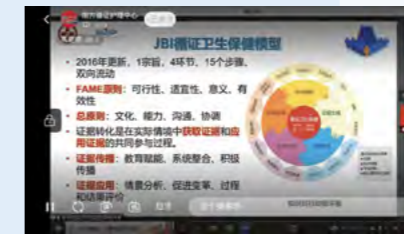
## Finding local solutions for implementing global evidence

The JBI gLocal Solution Room is a series of free events on evidence implementation held for, and by, practising professionals across the globe.

Hosted by JBI Collaboration Entities in multiple countries and languages, events include webinars, seminars, symposia and workshops, which are designed to help decision-makers and clinicians find pragmatic solutions to the challenges of implementing global evidence in their unique local settings.

- 23 JBI Collaboration Entities hosted local events in 2022 compared with 11 JBIC Entities in 2021
- Almost 30,00 healthcare professionals, policymakers and academics attended events online or in person across the globe, compared with over 1,600 in 2021
- JBI co-hosted a local event with the Australian Nursing & Midwifery Federation (SA Branch), attended by 200 healthcare professionals, students and academics

Every local event featured experts who formed a 'think tank' to use their collective expertise to respond directly to participants' questions about their unique contexts. Videos, reports and other resources from local events were made publicly available to facilitate knowledge exchange.

# JBI Endorsement



JBI Endorsement is a recognition awarded to healthcare organisations that demonstrate commitment to evidence-based healthcare and an organisation-wide culture of innovation and excellence.

In 2022, five organisations were officially recognised as JBI Endorsed healthcare organisations.

St Vincent's Health Network Sydney (Australia) was the latest organisation to achieve JBI Endorsed status.

In 2022, four health facilities – Zhongshan Hospital, Fudan University in Shanghai (China); Nanfang Hospital, Southern Medical University in Guangdong Province (China); Lausanne University Hospital in Lausanne (Switzerland); and University Hospital of São Paulo in São Paulo (Brazil) – maintained their JBI Endorsement status, following a reassessment of their compliance with JBI Standards and Criteria.

A review of the JBI Endorsement program brand was undertaken, and the program's visual identity was refreshed to reflect the prestige associated with achieving *JBI Endorsed* status.

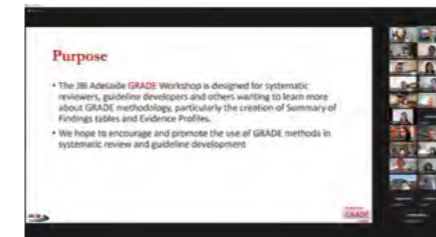
# Global Partnerships

In 2022, JBI played an active role in creating partnerships, collaborating with leading global organisations and leading a series of regional groups and organising committees internationally



## JBI Adelaide GRADE Centre

The JBI Adelaide GRADE Centre is the first GRADE Centre in Australia and New Zealand. The Centre was established in partnership with the GRADE Working Group, an international alliance of clinicians and researchers who have developed a leading approach to rating research quality and guideline development. The Centre's mission is to train, promote, disseminate and implement GRADE approaches within and across the systematic review and guideline development community globally.



Three GRADE workshops were conducted remotely for a total of 75 participants in 2022. This compares with a total of 44 participants in 2021. The JBI Adelaide GRADE Centre publishes the 'Australian GRADE Newsletter' in collaboration with the Melbourne GRADE Centre. Subscribers to the newsletter grew by almost 15% during 2022.



Australian GRADE Newsletter subscribers grew by almost **15%** during 2022.



Three GRADE workshops were conducted remotely with a **70.5% INCREASE** in participants over 2020.



## World Evidence-Based Healthcare Day

World Evidence-Based Healthcare Day, held on 20 October, is led by JBI. This initiative raises awareness of the need for better evidence to inform healthcare policy, practice and decision-making to improve health outcomes globally.



In 2022, official partners of JBI were Cochrane, Campbell Collaboration, Institute for Evidence-Based Healthcare, GIN, Centre for Evidence-based Health Care, and NICE. In 2022, the principal sponsor of World Evidence-based Healthcare Day was Wolters Kluwer Health.



## GIN

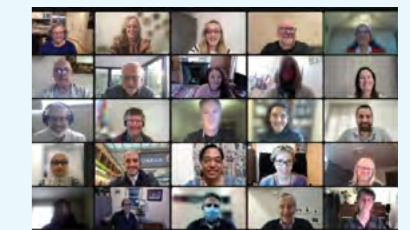
JBI facilitates the ANZ Regional Group of GIN (Guidelines International Network) and its ANZ Guideline Network, which comprises researchers, academics and professionals with a common interest in improving the health of Australians and New Zealanders through the development and implementation of evidence-based guidance and guidelines. JBI manages the administration of the Network, publishes newsletters and develops webinars.

In 2022, Prof Zachary Munn was the Chair of GIN. The GIN Conference was held in Toronto in September, and was attended by a number of presenting JBI staff.



## COVID-END

COVID-END is a time-limited network that brings together more than 50 of the world's leading evidence-synthesis, technology-assessment and guideline-development groups around the world. It covers the full spectrum of the pandemic response, from public-health measures and clinical management to health-system arrangements and economic and social responses. It also covers the full spectrum of contexts where the pandemic response is playing out, including low-, middle- and high-income countries.



# Philanthropy

Through the JBI Evidence-based Clinical Leadership Workshop, we aimed to meet the specific needs of clinicians, administrators, managers, clinical supervisors, regulators, policy makers, researchers, student midwives and midwifery educators in PNG.



## Australia Awards in Papua New Guinea

JBI delivered its Evidence-based Clinical Leadership Workshop as part of the Australia Awards in Papua New Guinea (PNG). The Midwifery Professional Development Workshop, conducted remotely (via Zoom) on 9 and 10 March 2022 (first workshop), was then repeated on 15 and 16 March 2022 (second workshop).

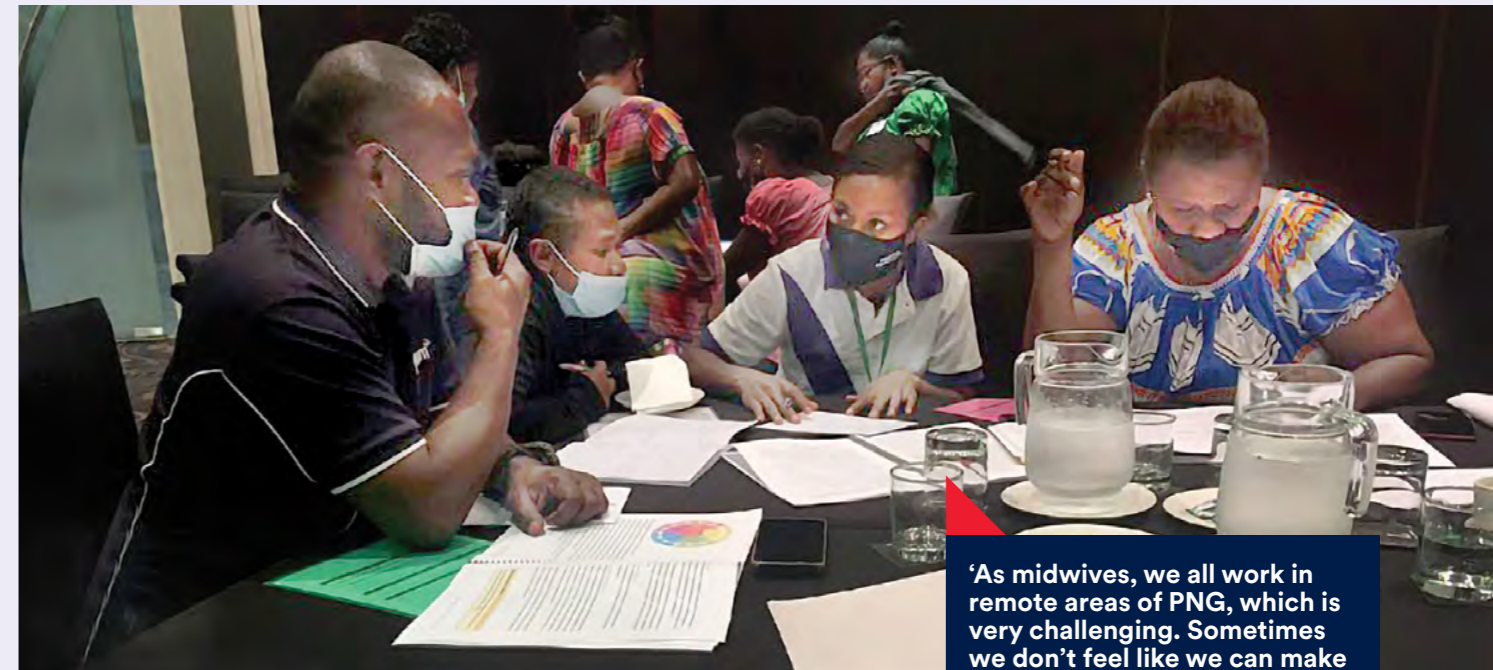
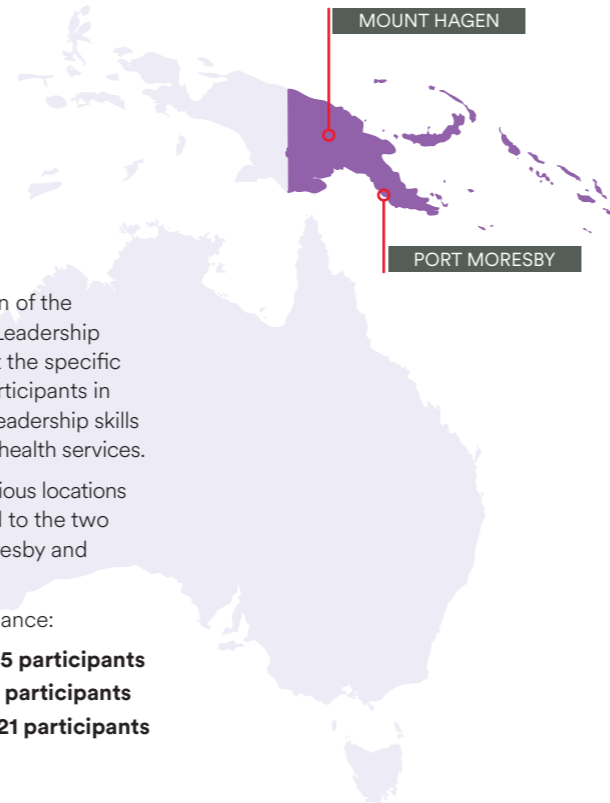
Building on the JBI Evidence-based Clinical Leadership workshops conducted in PNG in 2019 and 2020, the workshop was a tailored version of the one-day JBI Clinical Leadership Workshop presented over two days. Due to disruptions caused by the COVID-19 pandemic, these workshops had been delayed from 2021.

By delivering a tailored version of the JBI Evidence-based Clinical Leadership Workshop, we aimed to meet the specific needs of Australia Awards participants in PNG to further develop their leadership skills within local communities and health services.

The participants were from various locations across PNG and had travelled to the two workshop locations in Pt Moresby and Mt Hagen.

Participant numbers in attendance:

- Workshop 1 (Pt Moresby): **15 participants**
- Workshop 1 (Mt Hagen): **19 participants**
- Workshop 2 (Pt Moresby): **21 participants**



**'As midwives, we all work in remote areas of PNG, which is very challenging. Sometimes we don't feel like we can make any changes. This workshop has helped me to see that we can implement some evidence, and make some positive changes for the women in our care.'**

For the first time, JBI introduced two local PNG facilitators, who were present at each of the workshop locations, together with the JBI facilitators presenting online via Zoom. The workshop aimed to build the capacity of participants to manage, actively lead and facilitate change in their workplace. This included conflict resolution, negotiation, communication and building workplace culture based on current best practice.

- JBI Australia Awards in PNG Alumni Professional Development Workshop: 31 May and 1 June 2022. 'JBI Clinical Leadership Workshop.'

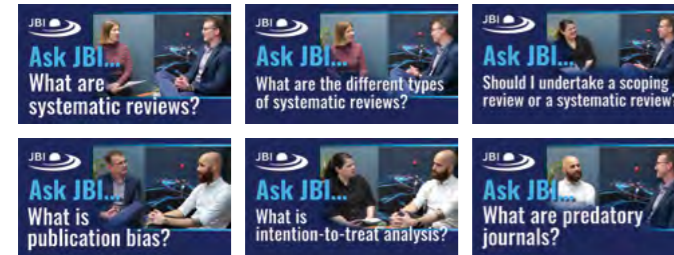

## JBI Evidence at Point-of-Care Methodology Group

The Evidence at Point-of-Care Methodology Group was established in 2022. This Group develops and provides oversight of the methodology and materials for JBI evidence-based point-of care resources that sit within the JBI EBP Database (Evidence Summaries, Recommended Practices and Best Practice Information Sheets).

## JBI Methodology Month

In April 2022, JBI piloted a digital media campaign, 'JBI Methodology Month'. The campaign coincided with the release of a special methodology issue of JBI Evidence Synthesis. The campaign highlighted the latest developments from JBI's unique methodologies and the free-access JBI resources available to students, clinicians, researchers, policymakers and others interested in evidence-based decision-making and evidence-based practice.

The campaign aimed to:

- communicate the strengths, value proposition and uniqueness of JBI methodology
- strengthen JBI's position as a leader in global EBHC
- extend JBI's reach online by raising awareness of JBI methodological resources, products and services webpages (in particular, the JBI Evidence Synthesis Special Issue).

The four-week digital campaign reached more than 1.6 million people.

## JBI Manual for Evidence Synthesis

The *JBI Manual for Evidence Synthesis* provides authors with a comprehensive guide to conducting JBI systematic reviews. There have been ongoing requests across the globe to make the information in the Manual more accessible to international audiences.

## JBI Critical Appraisal Tools and Risk of Bias

Members of the JBI Methodology Group for Reviews of Effectiveness have been reviewing all of the JBI critical appraisal tools for analytical quantitative studies. Revised critical appraisal tools and accompanying publications are due for release in early 2023.

### Evidence Synthesis Taxonomy Initiative

An NHMRC Investigator Grant formally commenced at the start of 2021 to advance the science of evidence synthesis. This collaborative initiative involves key stakeholders working across many scientific fields to establish an online, interactive and scalable evidence synthesis taxonomy wiki. A significant amount of meta-research (including scoping reviews), surveys, validation studies and Delphi approaches will be required to determine the current approaches, methodologies and methods in the field of evidence synthesis and to generate a taxonomy for guidance purposes.

### Australia's National Research Organisation for Women's Safety (ANROWS)

What works to reduce and respond to violence against women: evidence synthesis, methods and communication project. Four evidence gap maps are currently being finalised across prevention, early intervention, response and recovery.

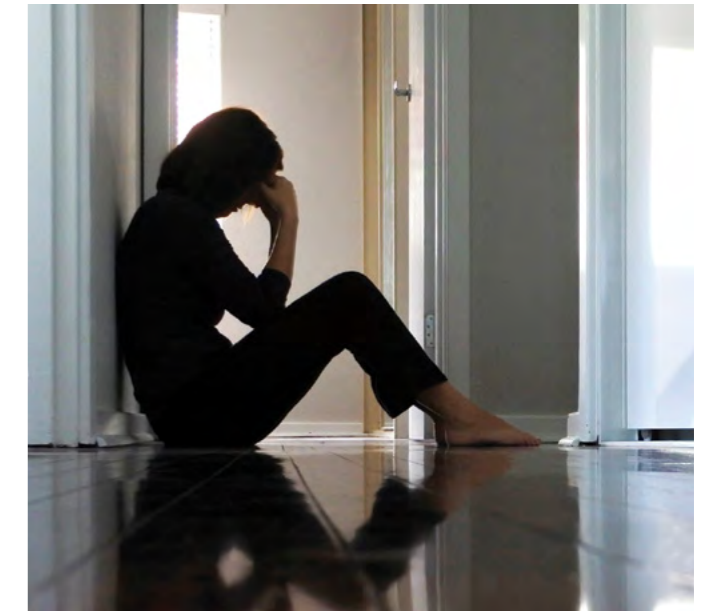

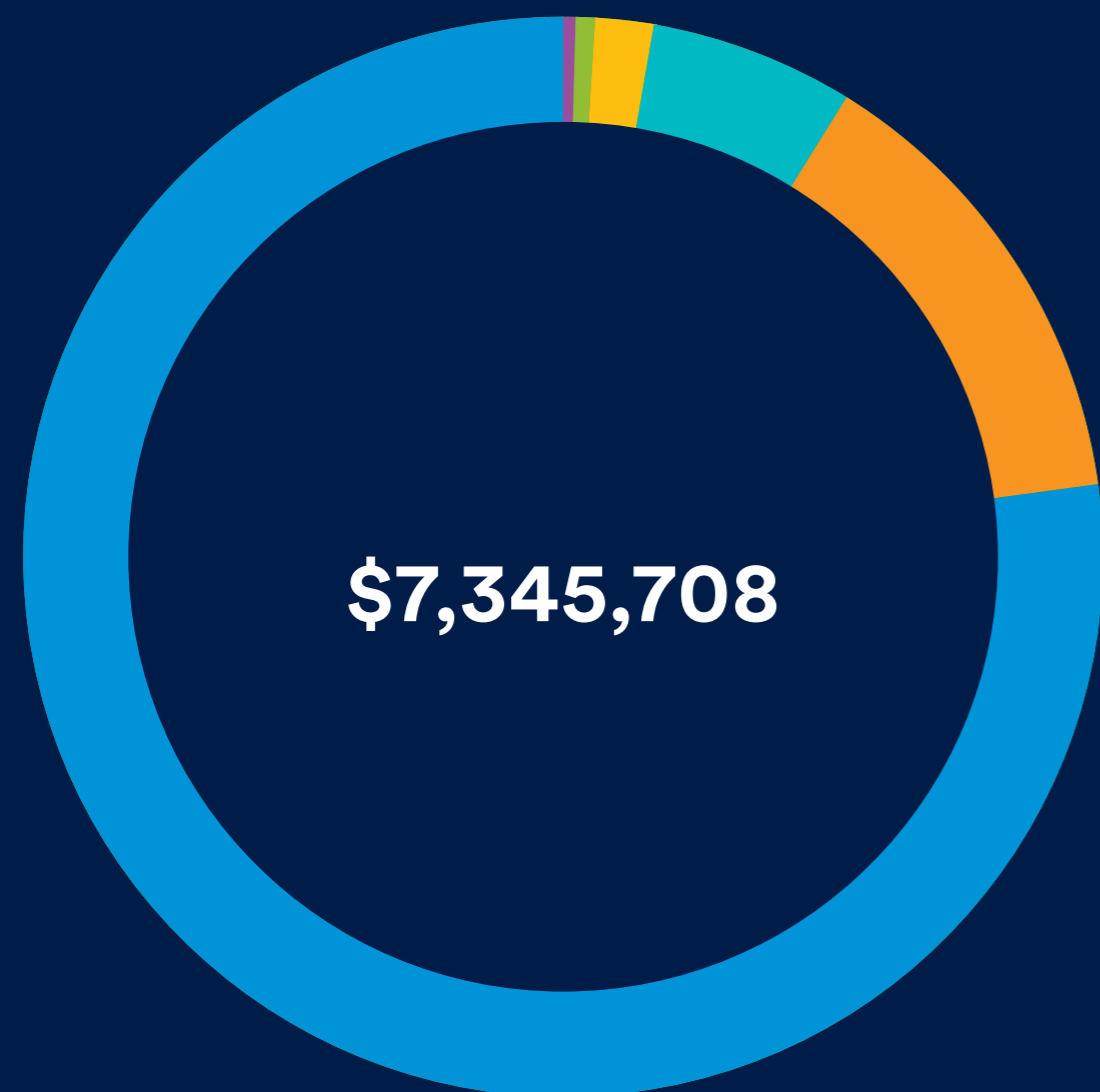
