
United Nations Sustainable Development Goal Commitment Statement



RESEARCH STRATEGY

JBI occupies a hybrid space that spans academia and industry, reflected in the integrated research strategy illustrated below.

With strong industry partnerships now established, our researchers are well positioned to apply for Category 1-2 competitive grants that can be utilised to increase our research translation capacity and achieve our scholarly endeavours. This unique model does not follow a traditional linear approach to research translation but instead employs an innovative methodology that delivers impact for global health. Research revenue from our industry partnership are reinvested to support ongoing research and development activity.





EBHC RESEARCH PROGRAM

JBI's EBHC Research Program seeks to respond to key challenges across the evidence ecosystem with a focus on closing the gap between the *science* and *practice* of evidence-based healthcare.

JBI's foundational scientific work is funded through a Research Translation Agreement with Wolters Kluwer Health. This significant Category 3 grant facilitates a global program of conceptual, methodological and applied research across the entire knowledge translation trajectory, encompassing the critical domains of global partnerships/networks, synthesis, transfer and implementation.

 Evidence synthesis methodology for questions relating to barriers and enablers in healthcare.

The number of evidence synthesis studies identifying factors that facilitate (act as 'enablers') or impede (act as 'barriers') the implementation of best practice in healthcare has significantly increased as researchers and clinicians strive to understand the evidence-practice gap. There is currently no consensus on the evidence synthesis approach for such topics, with the methods for analysing or synthesising results from studies varying across existing evidence reviews. A scoping review is currently underway at JBI to address this significant knowledge gap. With almost 800 included reviews, this research project will investigate the methodological aspects or processes related to the review of primary studies on barriers and/or enablers in healthcare. This includes barriers and enablers at different levels of healthcare, such as consumers of care, health practitioners, health organisations, policymakers and the community.

 JBI Evidence Synthesis and the United Nations Sustainable Development Goals.

In 2015, the United Nations agreed on 17 SDGs as the central framework for sustainable development worldwide. However, in the wake of the global pandemic, the 2030 SDG agenda is in jeopardy due to multiple cascading and intersecting crises. The Global Commission on Evidence has urged the evidence community to consider how it might more meaningfully contribute to the evidence architecture. As we pass the midway point to the SDG 2030 target date, it is timely to reflect on the contribution of those in the evidence synthesis community to achieving these important global objectives. JBI recently completed a pilot study to map the alignment of publications in JBI Evidence Synthesis to the United Nations Sustainable Development Goal (SDG) 3 (global health and well-being) and to understand JBI authors' awareness of and engagement with the goals. This will contribute to a largerscale analysis to assist the JBI Collaboration in working toward achieving the SDGs.

 Methodological components, structure and quality assessment tools for Evidence Summaries.

Evidence Summaries offer a practical solution to overcoming some of the barriers in evidence-based healthcare, such as lack of access to evidence at point-of-care; lack of knowledge; and lack of expertise to evaluate the quality and translate the evidence into clinical decision-making. However, lack of transparency in reporting and inconsistencies in the methodology of evidence summary development pose significant challenges for end-users (e.g. clinicians, policymakers). JBI recently completed a scoping review to identify and map the available information related to the definition, structure, core methodological components of evidence summaries and to identify any indicators of quality.

The findings of this review provide valuable insights on how to improve the credibility and transparency of evidence summaries in evidence-based healthcare. This will inform future research to develop recommended reporting guidelines and a robust critical appraisal tool for evidence summaries.

 Facilitation as a key element of evidence implementation.

Facilitation is a key element of evidence implementation. Although quantitative systematic reviews have been undertaken to examine its components and effectiveness, no attempt has been made to synthesise qualitative evidence examining the experiences of facilitators on how facilitation is operationalised, the challenges associated with it and the factors that can influence its effectiveness. This gap in knowledge was addressed by a recent qualitative systematic review which provided key insights into facilitation within evidence implementation. Drawing on facilitators' experiences, the research project uncovered important elements, influencing factors and challenges inherent in the implementation process.

 Development of a Meta-Epidemiological Dataset for Future Research

A research project is currently underway with support from the University of Adelaide's Faculty of Health and Medical Sciences to examine the impact of risk bias assessment items on research results. This involves the collection and standardisation of data from the Cochrane Database, specifically outcome data for included meta-analyses and risk of bias information. Data is subsequently mapped from the risk of bias assessment to a standardised list of items to allow for future evaluation of their impact on results. This meta-epidemiological dataset provides critical preliminary data for future research.

The JBI Effectiveness Reviews Methodology Group published the first of the revised JBI critical appraisal tools for quantitative evidence. Articles are presented as a series for 'risk of bias' in JBI systematic reviews in *JBI Evidence Synthesis*. The revised JBI critical appraisal tool for randomised controlled trials was published alongside introductory papers to launch the series in March (Issue 3) 2023. A companion series of articles on key concepts of risk of bias assessment is also included.

The JBI Scoping Review methodology is the most universally accepted and popular. The latest recommendations from the JBI Scoping Review Methodology Group for extracting, analysing and presenting results in scoping reviews were also published in March (Issue 3) 2023.

Multiple chapters for the *JBI Manual for Evidence Synthesis* are complete and major updates are underway for other chapters in the Manual, readying for the launch of the new edition in early 2024!



Use of evidence in the management of obesity in the primary sector (Funder: Research Australia)

Obesity is a significant and escalating health concern in Australia, requiring proactive measures for effective management. With new clinical guidelines anticipated in the coming year, this project will provide insights to support the effective dissemination of evidence-based guidance for the management of obesity across primary healthcare contexts. By addressing gaps in our understanding of the prevailing attitudes towards and preferences for accessing and utilising evidence, this project supports the dissemination of evidence-based guidance for the management of obesity across primary healthcare contexts. This enhances the quality of care provided to individuals grappling with obesity and contributes to broader efforts aimed at tackling this pressing public health challenge.

Investigating the potential effects of exposure to plastics on human health (Funder: Minderoo Foundation)

The global production and use of plastic materials have increased dramatically since the mid-twentieth century and there is a growing body of evidence on human health impacts related to exposure to plastic-associated chemicals. The Minderoo Foundation commissioned JBI to conduct an overview of meta-analyses investigating the potential effects of exposure to plastic-associated particles/chemicals on human health. This research will inform a broader program of activity which will include recommendations for future research and regulatory policy.

Identifying quality indicators to inform improvement in the quality of care of older people within the hospital setting (Funder: Registry of Senior Australians, South Australian Health and Medical Research Institute)

JBI was commissioned by the Registry of Senior Australians (ROSA) at the South Australian Health and Medical Research Institute (SAHMRI) to assist with a scoping review on the identification of quality indicators to improve the quality of care for older people in hospitals. This research forms part of a broader program funded by the Australian Government's Medical Research Future Fund to provide critical insights into key and currently unknown residential aged care impacts.

Improving the quality of medication administration practices in a tertiary Australian hospital (Funder: St Vincent's Hospital)

Medication safety is an important health priority seeking to prevent harm from medication-related events. Unsafe medication administration can lead to errors, which can cause avoidable injury (or harm) to patients. JBI was commissioned to support an evidence implementation initiative conducted in a large tertiary hospital in Australia to improve compliance with best practice recommendations for medication administration. The project involved multimodal strategies, including education, improved access to resources and targeted feedback and discussion sessions to encourage culture and behaviour change. The project resulted in improved compliance with best practice recommendations.











JBI EBP DATABASE

The JBI Evidence-based Practice (EBP) Database provides rapid access to trustworthy, evidence-based clinical decision support at the point of care - developed by clinicians for clinicians.





These resources are analysed and appraised by global expert reviewers to ensure that the most up-to-date information and best practices are provided.

It is the premier channel for diverse systematic reviews that move beyond effectiveness. All systematic reviews published apply JBI methodology and methods.

Exciting initiatives in 2023

Together with six other international scientific journals, JBI Evidence Synthesis co-published an important paper on conducting and reporting systematic reviews. 'Guidance to best tools and practices for systematic reviews' presented the various components of a systematic review and presented strategies and available tools for conducting a trustworthy review.

Nine translated abstracts of systematic and scoping reviews were submitted by authors proficient in languages other than English to accompany their reviews. The abstract translations included Arabic, Danish, Finnish, French, German, Japanese, Spanish and Vietnamese. The authors have responded enthusiastically with the opportunity to reach a wider audience with these translations.

In addition to launching the risk of bias article series, Methodology Month in March 2023 (Issue 3), included the latest recommendations from the JBI Scoping Review Methodology Group for extracting, analysing and presenting results in scoping reviews, one of our most

Key metrics from the journal platform

Ovid usage continued to increase in 2023. 223,395 Ovid sessions were opened in 2022, while 242,820 sessions were opened in 2023, an increase of 8%. Sessions opened on Ovid in 2023 led to 394.873 article views.

There has been an increase in submissions to the journal in 2023 for the first year since 2020. The journal received just over 100 more submissions than in 2022.

Editorials in motion

JBI Evidence Implementation Network

The quarterly supplement to the journal, the JBI Evidence Implementation eBulletin, has 2,733 subscribers - an increase of 5.5% from 2022 and an increase of 14% in the open rate. Submissions to the eBulletin also increased, with consistent contributions from senior members across the various fields of healthcare practice, including research, education and patient care.

The number of followers on X (formerly Twitter) grew to more than 10.7k in 2023. The journal has broadened its outreach by establishing a LinkedIn presence. The LinkedIn page has experienced remarkable growth, with follower numbers increasing by an average of 15%.



JBI's global collaborative evidence network, the JBI Collaboration (JBIC), spans 80+ universities, hospitals, health facilities and NGOs in 38 countries. These entities lead evidence-based initiatives in their community or region, directed by the knowledge needs of local clinicians and consumers.

The JBIC consists of JBI Centres of Excellence and Affiliated Groups. These entities are driven by a unified purpose—to improve the quality and outcomes of healthcare globally through the delivery of high-quality programs of evidence synthesis, transfer and implementation. The JBIC harnesses the diverse strength of its members to connect members in new and innovative ways. empowering them to work together, communicate and share knowledge. The network leverages existing resources to tackle large and complex problems in healthcare globally using JBI's approach to evidence-based healthcare.

2023 saw the return to face-to-face events, training and meetings. Many JBIC Entities began to resume the delivery of JBI short courses, both remotely (online) and face-to-face. GLOBAL PARTNERSHIPS

In 2023, JBI played an active role in fostering partnerships, collaborating with leading global organisations and leading a series of regional groups and organising committees globally.

JBI Adelaide GRADE Centre

The JBI Adelaide GRADE Centre is the first GRADE Centre in Australia and New Zealand. The Centre was established in partnership with the GRADE Working Group, an international alliance of clinicians and researchers who have developed a leading approach to rating research quality and guideline development. The Centre's mission is to train, promote, disseminate and implement GRADE approaches within and across the systematic review and guideline development community globally.

In 2023, Prof Zachary Munn and Dr Sue Brennan facilitated a webinar, 'GRADE for Guidelines', hosted by GIN ANZ and a total of 45 participants attended JBI Adelaide GRADE Centre workshops.

The JBI Adelaide GRADE Centre publishes the 'Australian GRADE Newsletter' in collaboration with the Melbourne GRADE Centre. Subscribers to the newsletter grew by 10% during 2023.



World EBHC Day

World Evidence-Based Healthcare Day, held on 20 October, is led by JBI in conjunction with six global leaders in evidence-based healthcare. This initiative raises awareness of the need for better evidence to inform healthcare policy, practice and decision-making to improve health outcomes globally. In 2023, official partners of JBI were Cochrane, Campbell Collaboration, Institute for Evidence-Based Healthcare, GIN, Centre for Evidence-based Health Care and NICE. In 2023, the principal sponsor of World Evidence-based Healthcare Day was Wolters Kluwer Health.



Guidelines International Network

JBI facilitates the ANZ Regional Group of GIN (Guidelines International Network) and its ANZ Guideline Network, which comprises researchers, academics and professionals with a common interest in improving the health of Australians and New Zealanders through the development and implementation of evidence-based guidance and guidelines. JBI manages the administration of the Network, publishes newsletters and develops webinars.



Global Commission on Evidence

The Global Commission on Evidence to Address Societal Challenges began two years ago as a grassroots effort to improve the use of research evidence, both in routine times and in future global.

JBI is a member of the Global Commission on Evidence Implementation Council.





Health Translation SA

Health Translation SA (HTSA) is a Research Translation Centre, accredited by the National Health and Medical Research Council (NHMRC) since 2015. Its core aim is to accelerate research findings into healthcare practice and policy and increase whole-of-system research translation capacity to improve the health of all South Australians. JBI contributes to the HTSA Implementation Science Network Executive Group, which develops a shared vision to scale and sustain the implementation science sector in South Australia.



Global Evidence Summit

The Global Evidence Summit, a quadrennial event, is a collaboration between four global leaders in evidence-based policy and practice, Cochrane, JBI, GIN and the Campbell Collaboration. It is a rare opportunity where global actors in evidence-based approaches will convene to share knowledge. The summit will serve as a crucial platform for collaboration to address global challenges in health, education, social justice and the environment. To be held in Prague, Czech Republic on 10-13 September 2024, the Global Evidence Summit represents a unique opportunity for professionals across various sectors to engage in discussions about evidence production, synthesis, translation, implementation and use. informing policy and practice.

The JBI gLocal Solution Room is a series of free events on evidence implementation held for and by practising professionals across the globe.

Hosted by JBI Collaboration Entities in multiple countries and languages, events include webinars, seminars, symposia and workshops, which are designed to help decision-makers and clinicians find pragmatic solutions to the challenges of implementing global evidence in their unique local settings.

- From 5-11 June 2023, 30 JBI Collaboration Entities hosted local events in 2023, compared with 23 entities in 2022.
- More than 30,000 healthcare professionals, policymakers and academics attended events online or in person in 20+ countries across the globe.
- JBI co-hosted two local events:

WORLD EBHC DAY



World Evidence-Based Healthcare (EBHC) Day is a JBI initiative that was launched in 2020 to raise awareness of the need for better evidence to inform healthcare policy, practice and decision-making to improve health outcomes globally.

World EBHC Day was held on 20 October 2023, led by JBI in partnership with Cochrane, Campbell Collaboration, GIN, the Institute for Evidence-Based Healthcare, the Centre for Evidence-based Health Care and NICE. The principal sponsor of World EBHC Day in 2023 was Wolters Kluwer Health.

In 2023, 1,106 organisations took part in World EBHC Day, an increase from 919 in 2022.

Across 122 countries and in 42 languages, 28.8 million people were reached across social media.

JBI **ignite**

JBI iGNITE is a two-day methodology symposium that was held for the first time on 16-17 November 2023. The symposium was attended by 200+ people from around the globe.



JBI iGNITE is designed to challenge and stimulate thinking about the future of EBHC methodology and methods, as the global evidence ecosystem continues to evolve at a rapid pace and the science of evidence-based healthcare becomes increasingly sophisticated.

The continued development of technologies such as Al and big data analytics have the potential to revolutionise EBHC methodology, together with the increasing emphasis on interdisciplinary and collaborative research approaches. JBI iGNITE is an opportunity to anticipate what the future might have in store for us and adapt to improve global health outcomes through the synthesis, transfer and implementation of the best available evidence.

Held at the National Wine Centre of Australia, the symposium featured presentations by international leaders and innovators in evidence synthesis and implementation.

Bespoke training

With funding from Australia Awards, JBI delivered a tailored version of the JBI Evidence-based Clinical Leadership Workshop in Port Moresby to 43 midwives who had travelled from various locations across Papua New Guinea.







The two-day workshop was specially developed to address the specific knowledge and cultural needs of the Australia Awards participants in Papua New Guinea to further develop their leadership skills within local communities and health services.

The workshop aimed to build the capacity of participants to manage, actively lead and facilitate change in their workplace. It also aimed to build workplace culture focused on applying current best practice in midwifery.




