EXECUTIVE DIRECTOR'S REPORT 2024

This year has been an extraordinary one for JBI as we continue to strengthen our commitment to evidence-based healthcare through global collaboration, innovation and impactful initiatives. I am pleased to share key highlights from our collective achievements and the strides we are making to realise JBI's vision of better health outcomes for all.

This year, we were thrilled to announce our continued partnership with Wolters Kluwer Health. Our new agreement will enable JBI's evidence-based resources to reach a broader audience through innovative dissemination channels. By leveraging Wolters Kluwer's platforms, we are poised to amplify the impact of JBI's methodologies, tools, and resources, ensuring they are accessible to healthcare professionals worldwide. This partnership reaffirms JBI's commitment to bridging the gap between evidence and practice to improve patient care on a global scale.

The JBI gLocal Solution Room looks at both how global knowledge informs local evidence-based practices and how local experiences influence global thinking in evidence-based healthcare. Each JBI gLocal Solution Room aims to catalyse these two forces, contributing to knowledge-sharing efforts globally, expediting the integration of evidence into practice. From 3–9 June this year, JBI and 36 JBI Collaborating Entities hosted 29 free events across 18 countries worldwide, including Romania, India, Denmark, Switzerland, Japan, Thailand, China, UK, US, Canada and Australia.

In October, JBI partnered with Cochrane, Guidelines International Network (GIN) and Campbell Collaboration to deliver the highly successful Global Evidence Summit in Prague, which brought together leading organisations and stakeholders in evidence synthesis. As part of this landmark event, the JBI Collaboration held its Annual General Meeting, celebrating our community's growth and reaffirming our shared goals.

The discussions emphasised advancing methodological rigour, enhancing capacity-building efforts, and fostering diversity within the evidence synthesis community. The Prague summit not only reinforced the global network's role in evidence translation but also underscored the power of collaboration across disciplines and regions.

We also celebrated World Evidence-Based Healthcare Day in October, shining a spotlight on the critical role of evidence-based practice in achieving global health goals. The campaign this year centred on, Health and Beyond: From Evidence to Action, and highlighted the importance of collective wisdom and collective action in the form of large-scale strategic collaboration, including actors from across the evidence ecosystem. We were overwhelmed by the level of engagement this year, reaching over 80 million people!

This year also marked a milestone in our leadership of the global evidence synthesis field. JBI has been privileged to co-lead the 'Building a Global Evidence Synthesis Community' initiative alongside Karla Soares-Weiser (Cochrane). Will Moy (Campbell Collaboration) and John Lavis (McMaster University). This initiative seeks to unite researchers, clinicians. policymakers and evidence users in addressing global health challenges through a shared platform for collaboration and knowledge exchange. Together, we aim to build a sustainable and inclusive community that transcends geographic and disciplinary boundaries to improve health systems and outcomes globally.

Our reinvigorated research program has already yielded remarkable outcomes. We have secured two Australia Awards Fellowship Programs, a National Health and Medical Research Council (NHMRC) Investigator Grant, and multiple other funded projects. These accomplishments reflect the dedication of our researchers and the growing recognition of JBI's role in advancing healthcare research.

The Australia Awards Fellowship Programs, in particular, highlight JBI's contribution to capacity-building in low- and middle-income countries, fostering sustainable research ecosystems and empowering local healthcare leaders.



JBI made solid progress towards its strategic goals in 2024:


Equity, Diversity and Inclusion commitment

In 2024, JBI entered into a Research Translation Agreement with Wolters Kluwer Health. This substantial grant will support the significant expansion of JBI's research operations, solidifying its role as a global leader in evidence-based healthcare. The agreement will facilitate a global program of conceptual, methodological and applied research across the entire knowledge translation trajectory, encompassing the critical domains of global partnerships/networks, synthesis, transfer, and implementation. It aims to address key challenges across the evidence ecosystem, with a focus on bridging the gap between the *science* and *practice* of evidence-based healthcare.

Research translation partnership with Wolters Kluwer Health



Global evidence-based practice study: understanding attitudes, practices and preferences of healthcare professionals working in primary, acute and residential aged care settings

The rapid proliferation of information and emergence of new technologies has the potential to synthesise and deliver evidence to support decision-making at the point of care. This presents new opportunities and challenges for evidencebased healthcare. As methodologists and evidence producers navigate emerging technologies, it is paramount that they prioritise the attitudes, practices and preferences of healthcare professionals. Doing so will ensure that developments in the field are ultimately translated into practical solutions that support the integration of evidence into routine practice.

For this reason, JBI is undertaking a global study to investigate how and when health professionals and carers seek and access evidence to inform decision-making at the point of care. As part of this project, we are seeking an understanding of current attitudes, practices and preferences of general practitioners, nurses, allied health professionals and carers working in primary, acute and residential aged care

The project will address knowledge gaps, allowing us to better understand facilitators and barriers to the incorporation of evidence into day-to-day practice. This knowledge will equip evidence producers, healthcare organisations and government departments to develop resources and strategies for the practical integration of evidence into healthcare structures and practice across the globe.

Investigating the potential effects of exposure to plastics on human health

The global production and use of plastic materials has increased dramatically since the mid-twentieth century and there is a growing body of evidence on human health impacts related to exposure to plastic-associated chemicals.

The Minderoo Foundation commissioned JBI to conduct an overview of metaanalyses investigating the potential effects of exposure to plastic-associated particles/ chemicals on human health. This research will inform a broader program of activity which will include recommendations for future research and regulatory policy.

Utilisation of evidence in the management of obesity in the primary sector

JBI has been commissioned by Research Australia to conduct a multi-phased research project to provide insights into the management of obesity. In particular, the project will investigate the preferred methods for accessing and using evidence in decision-making by health professionals working in primary health settings, with a specific focus on the management of obesity.

Obesity stands as a significant and escalating health concern in Australia, necessitating proactive measures for effective management. With new clinical guidelines anticipated in the coming year. this project will provide insights to support the dissemination of evidence-based guidance for the management of obesity across primary healthcare contexts. A better understanding of the prevailing attitudes and preferences for accessing and utilising evidence will ultimately enhance the quality of care provided to people grappling with obesity and bolster broader efforts to tackle this pressing public health challenge.

Evidence synthesis methodology for questions relating to barriers

and enablers in healthcare

The number of evidence synthesis studies identifying factors that facilitate (act as 'enablers') or impede (act as 'barriers') the implementation of best practice in healthcare has significantly increased as researchers and clinicians strive to understand the evidence-practice gap. There is currently no consensus on the evidence synthesis approach for such

topics, with the methods for analysing

or synthesising results from such studies

varying across existing evidence reviews.

A scoping review is currently underway at JBI to address this significant knowledge gap. With almost 800 included reviews. this research project will investigate the methodological aspects or processes related to the review of primary studies on barriers and enablers in healthcare. This includes barriers and enablers at different levels of healthcare, such as consumers of care, health practitioners, health organisations, policymakers and the community.

Cracking the Code: Assessing Al's Role in Mapping Evidence Syntheses to the UN Sustainable **Development Goals**

As we pass the midway point to the 2030 Sustainable Development Goal (SDG) agenda, the global evidence community faces increasing pressure to demonstrate how its work contributes to advancing these critical global targets. Recognising the importance of systematic research alignment, JBI conducted a pioneering study to evaluate whether artificial intelligence (AI) technologies reliably map published evidence syntheses to SDG 3: Good Health and Wellbeing.

Building on a 2022 pilot study that manually assessed the alignment of JBI reviews to SDG 3, this new project compared human mapping with Al-driven classification systems used by leading databases. A total of 204 systematic and scoping reviews published in JBI Evidence Synthesis were evaluated by the four methods.

The study found that only 52% of publications were consistently classified across all raters, with overall inter-rater reliability indicating "minimal agreement". These findings underscore the urgent need for standardised, transparent, and scalable approaches to SDG mapping, particularly as AI continues to influence research visibility and policy alignment.

Methodological components, structure and quality assessment tools for JBI Evidence Summaries

JBI Evidence Summaries offer a practical solution to some of the barriers in evidence-based healthcare. Such barriers include lack of access to evidence at the point of care; insufficient knowledge; and insufficient expertise to evaluate the quality and translate the evidence into clinical decision-making. However, lack of transparency in reporting and inconsistencies in the methodology of evidence summary development poses significant challenges for end users (e.g. clinicians, policymakers).

JBI recently completed a scoping review to map the available information on the definition, structure and core methodological components of evidence summaries, and to identify any indicators of quality. This research will provide critical insights on how to improve the credibility and transparency of evidence summaries in evidence-based healthcare. This will inform future research to develop recommended reporting guidelines and a robust critical appraisal tool for evidence summaries.

Facilitation as a key element of evidence implementation

Facilitation is a key element of evidence implementation. Quantitative systematic reviews have been undertaken to examine its components and effectiveness; however, no attempt has been made to synthesise qualitative evidence examining the experiences of facilitators on how facilitation is operationalised, the associated challenges and the factors that can influence its perceived effectiveness. This gap in knowledge was addressed by a recent qualitative systematic review which provided key insights into facilitation in evidence implementation. Drawing on facilitators' experiences, the research project uncovered crucial elements, influencing factors and challenges inherent in the implementation process.

Development of a metaepidemiological dataset for future research

A research project is currently underway with support from the University of Adelaide's Faculty of Health and Medical Sciences to provide insights into the impact of risk bias assessment items on research results. This involves the collection and standardisation of data from the Cochrane database, specifically outcome data for included meta-analyses and risk of bias information. Data is subsequently mapped from the risk of bias assessment to a standardised list of items, to allow for future evaluation of their impact on results. This meta-epidemiological dataset provides critical preliminary data for future research.

Investigation of methodology, reporting and suggested practices for conducting systematic reviews aetiology and risk factors

The increasing importance of translating research into policy and practice has boosted interest in systematic reviews and metaanalyses to judge the trustworthiness of the results of research. There has been a proliferation of educational programs and methodological guidance from authoritative bodies for conducting systematic reviews of intervention effectiveness (i.e. reviews of clinical trials). However, systematic reviews of aetiology of disease and risk factors are also critically important in the public health domain for informing health care planning, resource allocation and strategies for disease prevention. Yet, such reviews have received far less attention. There are numerous issues associated with these systematic reviews, including the combining of different observational study designs in the same synthesis, risk of bias assessment using summary scores, choice of meta-analytic model, credibility ceilings, unit of analysis errors, and combining unstandardised exposure measurements.

Moreover, literature on conducting such reviews is sparse and provides contradictory recommendations, urging the need for more robust protocols.

This research funded by a National Health and Medical Research Council (NHMRC) Investigator Grant involves a comprehensive investigation of errors, methodologies and suggested practices for conducting systematic reviews on disease causation and risk factors. The goal is to establish a cohesive framework for developing methodological guidance, educational resources and capacity-building initiatives in the field. The outcomes of this project, including products, guidance and education, will fulfil a significant unmet need and contribute new knowledge on the synthesis of observational studies. These insights will be used to shape evidence-based decision-making, with direct translation to health policies and recommendations for health research.

Review of evidence about disease risk associated with low-level asbestos exposure

This research project will support the Asbestos and Silica Safety and Eradication Agency (ASSEA) to understand and communicate the health risks associated with low-level asbestos exposure and inform future research and risk communication strategies. The primary objective of the project will be to conduct a comprehensive rapid review of low-level asbestos exposure and human health risk. The project will assess the association between such exposure including the effects of cumulative lowlevel exposure in various settings - and the development of asbestos-related diseases. JBI will use a methodologically sound, thorough approach to the rapid review to deliver recommendations that will assist ASSEA.

JBI METHODOLOGICAL PROGRAM

JBI is a global leader in diverse research methodologies that guide the conduct of evidence synthesis, transfer and implementation to improve health and health service delivery.

2024 Highlights

- The JBI Manual for Evidence Synthesis was reviewed and revised. The 2024 Edition was launched during JBI Methodology Month in March.
- The JBI Aetiology and Risk Methodology Group was established. The Group submitted an application for a PRISMA Extension, which has since been approved and will make a significant contribution to enhancing reporting standards for systematic reviews of aetiology and risk.
- The JBI Economic Reviews Methodology Group re-formed in 2024 and held its first meeting in September.
- The JBI Effectiveness Reviews Methodology Group completed and published risk of bias tools for cohort and case control studies, providing researchers with the resources to assess study quality, in alignment with GRADE.
- The JBI Mixed Methods Systematic Review Methodology Group finalised guidance on data extraction and data transformation in convergent mixed methods systematic reviews, culminating in a manuscript that was published in the JBI Evidence Synthesis journal (Vol 23, Issue 3).
- The JBI Qualitative Reviews Methodology Group strengthened collaborative relationships with the Cochrane-Campbell Equity Group and co-presented a workshop at the Global Evidence Summit titled, 'Health equity and implications for evidence synthesis.' Extensive updates of the qualitative reviews chapter in the JBI Manual for Evidence Synthesis are almost complete.
- The JBI Scoping Reviews Methodology Group published four articles in the Journal of Clinical Epidemiology and Research Synthesis Methods. Membership of the JBI Scoping Review Network grew to 1,900.
- The Textual Evidence Systematic Reviews Methodology Group released a new chapter update to the JBI Manual for Evidence Synthesis in the second half of 2024. Three separate critical appraisal tools (narrative, expert opinion and policy) were also published.

The 2024 Edition of the JBI Manual for Evidence Synthesis reflects the latest methodological developments and feedback from end users to give researchers and authors access to the most comprehensive and up-to-date guidance for conducting various types of evidence syntheses.



Many chapters have been revised, with revision of all chapters ongoing into 2025. In addition, a 'Resources' section was added to each chapter providing links to supplementary resources.


New information was also added to the Manual on Equity, Diversity and Inclusion; Synthesis Prioritisation; and Living Evidence considerations for evidence syntheses.

A new section was added to include methodological guidance on activity relevant to all syntheses (searching, languages other than English, knowledge user engagement and predatory publishing).

Three chapters were removed to reduce duplication. External methodologies for systematic reviews of prevalence and incidence, systematic reviews of diagnostic test accuracy, and systematic reviews of measurement properties have been endorsed for adoption by the JBI Scientific Committee. 




13 abstracts of systematic and scoping reviews in languages other than English were published, including Chinese, Danish, Finnish, French, German, Japanese, Norwegian and Spanish. These abstracts aim to engage health professionals in their primary language.

11 Editorial in Motion videos were created by the communications team to further disseminate research presented in the journal. We also introduced our first two videos on how to peer review for *JBI Evidence Synthesis*.









Key metrics from the journal platform

Ovid usage increased again in 2024. In 2023, a total of 242,820 Ovid sessions was opened, compared with 258,345 sessions in 2024, an increase of 6%. Sessions opened on Ovid in 2024 led to 494,379 article views.

Submissions

The journal received submissions from 51 countries in 2024, a marked increase from 43 countries in 2023. Journal submissions decreased to 563 in 2024, which was nearly 100 fewer than in 2023. This decrease is mostly due to a drop in protocol submissions. Conversely, the number of quantitative reviews, scoping reviews, diagnostic test accuracy reviews and umbrella reviews increased in 2024 compared with 2023.

The overall manuscript acceptance rate in 2024 was 28%, a slight decrease from 30% in 2023.



JBI Evidence Synthesis Impact Award

In 2024, the inaugural JBI Evidence Synthesis Impact Award was presented to authors of the review, 'Effect of dexamethasone administration for post-operative nausea and vomiting prophylaxis on glucose levels in adults with diabetes undergoing elective surgery: a systematic review with meta-analysis.' The review was chosen by a panel of editors based on its potential to improve practice, in line with the mission of JBI.



JBI EVIDENCE IMPLEMENTATION

JBI Evidence Implementation is a theory-informed and pragmatically focused journal, publishing case studies and papers from diverse clinical, cultural and socio-economic contexts. These publications address the science and practice of evidence implementation into healthcare policy and practice.



Highlights

- The journal's impact factor increased from 2.3 to 2.7.
- The journal's ranking in key databases has increased in 2024 to rank 60th in the Healthcare Science & Services category (up from 72nd in 2023) and 67th in Medicine, General & Internal (up from 100th in 2023).
- 12 video commentaries on published articles were developed.







• 2024 saw a 16% increase in the number of Ovid sessions.

Other highlights include improved service for authors by reducing the time from submission to final disposition (the time from first submission to uploading a copy edited and formatted manuscript to our publisher in readiness for publication) from 400 days to under 200.

The annual total number of full articles read through Ovid institutional access increased by 22% in 2024. There was a total of 116,191 visits to the journal's online platform in 2024, with 43,736 new visitors. The total number of page views in 2024 was 183,070.

Submissions

The journal received 151 submissions in 2024, an increase from 145 submissions in 2023. The acceptance rate in 2024 was 83.9%.






JBI SUMARI product updates

In 2024, extensive work was undertaken to enhance the screening process in JBI SUMARI, allowing for the simultaneous import of files, larger file sizes, the ability to delete or undo imported files, the automatic elimination of exact duplicates and the identification of potential duplicates.

The updates also include integration of the new randomised control trial critical appraisal tool, enhanced user interface and user permission levels. Beta testing is scheduled for 2025.

JBI PACES (Practical Application of Clinical Evidence System) is software that facilitates the conduct of quality improvement projects, audit and feedback cycles and evidence implementation projects.

JBI PACES product updates

2024 saw the release of the completely re-built GRiP (Getting Research into Practice) module. This module is embedded within PACES. The new GRiP enables users to build in domains or categories linked to implementation science or behavioural theories, models and frameworks. This enhances implementation and improves the fidelity of reporting and action-taking. It also provides direct linkage between individual quality indicators and barriers, strategies and enablers.

In addition, 20 new audit criteria topics developed by JBI have been integrated into JBI PACES, bringing the total number of audit criteria topics to 575. Customising or adding individual audit criteria that are organisation-specific is now easier and faster.

JBI's global collaborative evidence network, the JBI Collaboration (JBIC), spans 80+ universities, hospitals, health facilities and NGOs in 43 countries. These entities lead evidence-based initiatives in their community or region, directed by the knowledge needs of local clinicians and consumers.

The JBIC harnesses the diverse strengths of its members to benefit and connect members in new and innovative ways, empowering them to work together, communicate and share knowledge. The network leverages existing resources to tackle large and complex problems in healthcare globally using JBI's approach to evidence-based healthcare.

As a global collaborative evidence network, the JBIC has maintained its strength and continues to share and collaborate with colleagues from around the world in promoting evidence-based healthcare. The 72nd JBIC Meeting was held in person in Prague, Czech Republic, in September, prior to the highly anticipated Global Evidence Summit.

Across three days, we met with 132 JBIC directors, convenors, deputies and staff from five regions where we discussed the interim results of the JBIC Brighter Future grant projects, held roundtable discussions on the relevance of the JBI Activity Matrix and operational framework to JBI's mission and vision and planned the way forward for 2024–25.

In 2024, JBI and the JBIC conducted a JBIC Strategic Review to determine whether the form, functions, activities, systems and policies of the current JBIC Activity Matrix Framework are Feasible, Appropriate, Meaningful and Effective. The aim was to identify whether the matrix was suitable for current JBIC Entities, sustainable for a growing collaborative evidence network and whether it achieved its goal of supporting JBI entities to engage with activities that promote evidence-based healthcare globally.

The strategic review was conducted over 12 months and five phases, including a desktop audit, financial analysis, JBIC survey, a JBIC regional review and an interactive roundtable discussion. The results of this review informed the update of the 2025 JBIC Handbook and operational framework, with a significant expansion of JBIC Activities co-created with JBIC members.

We were pleased to welcome three new Affiliated Groups in 2024: from Mahidol University, Bangkok Thailand; X University, Wrocław, Poland; and University of Piemonte Orientale from Piedmont, Italy.

We are proud to acknowledge 50 Centres of Excellence and 38 Affiliated Groups as a part of the global JBI family in 2024.



The JBI Collaboration (JBIC) Brighter Futures Grant Program is a biennial funding initiative established to support innovative, collaborative and equity-focused initiatives across the JBI's global collaborative evidence network.

The Grant Program was designed to strengthen capacity in lowand middle-income countries, enhance multilingual engagement and foster inter- and intra-network collaboration. The program provides funding for activities aligned with JBI's evidence synthesis, transfer and implementation priorities.

Launched in 2023, the inaugural round of the Brighter Futures Grant Program funded ten different two-year projects spanning 13 countries and a range of health topics, methodologies and populations. These projects reflect the diversity, innovation and equity focus of the JBIC and have already generated meaningful early outcomes. As of mid-2024, each project submitted an interim report detailing progress against planned milestones. These reports reveal promising trends in evidence use, strengthened global partnerships and enhanced capacity for evidence-informed decision-making, particularly in underrepresented regions and multilingual contexts.



Australia and Jordan

Project: Assessment and implementation of strategies to promote evidence-based diabetes care in Jordan

This project sought to increase healthcare professionals' capacity to promote evidence-based diabetes care within educational and clinical practice in Jordan. Led by Edith Cowan University in partnership with the University of Jordan, the project delivered the JBI Comprehensive Systematic Review Training Program to 20 Jordanian researchers and clinicians. Review teams are progressing three protocols and one active systematic review on digital interventions for children with diabetes. The initiative is strengthening JBI's presence in the Middle East and fostering cross-regional mentorship.

Australia and Hong Kong

Project: Exploring clinical incident analysis in healthcare: a scoping review and ethnography study

Led by the Queensland Centre for Evidence Based Nursing and Midwifery (Brisbane) in collaboration with the Charles Darwin Centre for Evidence-Based Practice (Darwin) and the Centre for Research in Nursing and Health (Sydney), this two-phase project investigates the models, processes and barriers to clinical incident analysis in healthcare, including how patients and families are engaged. Phase 1 involved a scoping review of 100 studies (final report pending submission), while Phase 2 comprises an ethnographic study across Mater Health facilities in Queensland. Despite personnel changes, an ethnographic study at Mater Health facilities has commenced, with findings expected to inform the improved patient safety frameworks.

Belgium and Switzerland

Project: Building bridges in research: a multilingual international collaboration

Led by JBI Belgium in partnership with the Swiss BEST Centre, this project builds bridges across linguistic and institutional boundaries to strengthen evidence-based healthcare research and education. The initiative launched a formal mentorship program between the two centres, sharing best practices and adapting strategies from the Swiss context to enhance visibility, training and governance structures in multilingual Belgium. A key outcome was the establishment of a bilingual JBI Comprehensive Systematic Review Training Program and the formation of multilingual review teams. Despite recruitment challenges across language groups, collaboration was fostered through cross-linguistic pairings and targeted mentoring. To explore barriers and enablers of multilingual teamwork, a qualitative study was conducted, identifying themes such as communication challenges, cultural interpretation and the importance of open-minded collaboration. Outputs to date include a joint presentation at the JBI European Symposium, LinkedIn dissemination and submission of a thesis on multilingual research dynamics. The project continues to inform inclusive practices for evidence generation in diverse contexts.

Brazil

Project: Knowledge translation and evidence implementation: from organizational readiness to the impacts, challenges and perspectives of health professionals from Brazilian health institutions.

Led by the Brazilian Centre for Evidence-based Healthcare: A JBI Centre of Excellence, this study evaluates organisational readiness for evidence implementation by translating and applying the Organizational Readiness for Knowledge Translation (OR4KT) tool in Brazilian hospitals. In 2024, the team translated the instrument and is currently working with expert reviewers to finalise its validation. Once validated, the tool will be used to assess readiness among nurses in both public and private hospitals in São Paulo.

Alongside this, ten nurses completed the first stage of JBI's Evidence Implementation Training Program and are now developing implementation projects in public healthcare settings. A pilot qualitative study has also been conducted to explore nurses' perspectives on evidence-based practice, revealing key themes related to institutional support, sustainability and the value of nursing leadership. Despite delays related to ethics approvals and participant recruitment, the project is progressing and will inform future strategies for building evidence-based practice capacity and improving health system performance in Brazil.

Canada, Colombia, Chile and Peru

Project: Domestic violence and older women's health in Latin America

Led by Aligning Health Needs and Evidence for Transformative Change: A JBI Centre of Excellence, in collaboration with South America EBHC: A JBI Affiliated Group, this scoping review explores the impact of domestic violence on midlife and older women in Latin America—an under-researched and often overlooked population. The project aims to map the existing evidence base across multiple Latin American countries and strengthen South—North research partnerships through formal mentorship and shared methodology.

Despite initial challenges—including a pivot from an effectiveness review due to limited data and technical barriers in searching regional databases—the team completed rigorous screening of 16,861 titles and abstracts and 134 full texts, ultimately including 17 studies for review. It has also provided hands—on training to PhD and undergraduate students from Colombia, Chile and Peru. Despite challenges accessing regional databases, the team developed tools to support consistent screening and data extraction. The protocol was submitted to BMJ Open and a toolkit is being developed to aid others working with Latin American literature.

PR China and Indonesia

Project: Management of musculoskeletal symptoms in breast cancer patients undergoing endocrine therapy

Led by the Fudan University Centre for Evidence-based Nursing: A JBI Centre of Excellence, in collaboration with the Dali University Hospital and the University of Indonesia Hospital, this multicentre implementation project targets improved care for breast cancer survivors experiencing musculoskeletal symptoms from aromatase inhibitor therapy. Using the JBI Evidence Implementation Framework, audit criteria were developed and applied across Chinese and Indonesian sites. Early results show improved adherence and reduced pain symptoms, with robust training and digital tracking systems ensuring consistency across sites. The project is strengthening existing linkages and promoting practical cooperation with three hospitals. It is also helping to build understanding and exchange in the public health response to breast cancer care, leading to an innovative solution to address a shared pressing need of breast cancer care in China and Indonesia.

PR China, Thailand, India, the Republic of Korea, Myanmar and Kazakhstan

Project: Nausea and vomiting management of patients undergoing chemotherapy: a multicentre best practice implementation project

Led by the China Nanfang Nursing Centre for Evidence-based Practice: A JBI Centre of Excellence, this multinational project involved ten JBIC Entities across six countries, aiming to reduce chemotherapy-induced nausea and vomiting. Using JBI's Evidence Implementation Framework, the team developed six audit criteria and tailored multilingual strategies, including educational materials, videos and care workflows, to suit each hospital's context.

Barriers to best practice were identified through a structured questionnaire, enabling evidence-informed interventions supported by expert recommendations. Interim results showed significant improvements, with compliance rates rising from 0% to between 45% and 85% and notable reductions in patient nausea. The project demonstrates the power of cross-country collaboration and context-sensitive implementation to improve patient outcomes.

Indi

Project: Central venous access device management in critical care units: a multicentric implementation project in a low-resource setting

Led by the Pushpagiri Centre for Evidence-Based Practice, a JBI Centre of Excellence, this multicentre project aimed to prevent central line-associated bloodstream infections by evaluating and improving central venous access device practices in intensive care units across three hospitals in Kerala. The team developed JBI-informed audit criteria, conducted baseline assessments and implemented staff training despite operational challenges. Early findings show an infection incidence of 1.44%, with pathogens identified and quality improvement strategies underway. The findings of the project will be disseminated through publications, conferences, manuals and posters in English, Malayalam, Tamil and Hindi for wider use among critical care staff in India.

Scotland

Project: JBI Allied Health Professional Evidence Synthesis Fellowship

Led by the Scottish Centre for Evidence-Based Multi-Professional Practice: A JBI Centre of Excellence, this project builds capacity among NHS allied health professionals (AHPs) in Scotland to develop evidence synthesis knowledge, skills and practical experience. This will allow AHPs to undertake evidence syntheses to inform clinical practice, to be critical consumers of evidence and to identify areas of research need. Eight AHPs completed JBI's Comprehensive Systematic Review Training Program and are progressing reviews in fields such as podiatry, dementia care and speech therapy. Four protocols are in development. AHPs report greater confidence in evidence-based leadership, with institutional support key to enabling dedicated review time.

USA, Cameroon, Ethiopia, India, Nigeria, Rwanda, Sri Lanka and Zimbabwe

Project: Building Global Capacity for Inclusivity in Academic Publishing

Led by the Northeast Institute for Evidence Synthesis and Translation: A JBI Centre of Excellence, this project builds academic publishing capacity among health scholars from lowand middle-income countries (LMICs) through a structured training and mentorship pathway. 49 participants completed JBI's Comprehensive Systematic Review Training Program, with nine advancing to peer review training, manuscript assessment and participation in editorial board meetings for AJPM Focus. Three LMIC-led systematic reviews are now underway on key global health topics, including cardiovascular disease prevention and the burden of rare diseases. While engagement in later stages was lower than expected, participants who completed all components demonstrated strong commitment and are being considered for editorial roles. The project's reach and relevance have been showcased through presentations at the Council of Science Editors and the Global Evidence Summit.

A joint statement was read at the closing session of the Global Evidence Summit in Prague by Prof Zoe Jordan, Executive Director of JBI.

Following the announcement, Prof Jordan (JBI), Dr Karla Soares-Weiser (Cochrane Collaboration) and Will Moy (Campbell Collaboration), agreed to co-lead the Building a Global Evidence Synthesis Community initiative.

This has evolved into the Evidence Synthesis Infrastructure Collaborative (ESIC), funded by the Wellcome Trust, which is now underway, in partnership with the United Nations Global SDG Synthesis Coalition, the Pan-African Collective for Evidence (PACE) and the Centre for Rapid Evidence Synthesis (ACRES). The ESIC planning process commenced in 2024 with open consultation and global-scale collaboration. A key focus was on ensuring diverse and inclusive representation across regions and sectors. The planning process will continue into 2025, culminating in a consensus meeting in Cape Town in June 2025, with the aim of delivering a 'menu of options' for funders to support the evolution of evidence synthesis across sector and geography.

































GLOBAL EVIDENCE SUMMIT

JBI partnered with Cochrane, GIN and Campbell Collaboration to deliver the Global Evidence Summit in Prague, Czech Republic, 10–13 September 2024.

The purpose of the Global Evidence Summit was to provide a multidisciplinary and cross-cultural platform to facilitate collaboration around producing, summarising, disseminating and implementing evidence to improve lives.

Almost 2,000 delegates from 73 countries gathered to help shape the future of evidence synthesis and implementation.

Delegates attended 60 workshops, 25 special sessions, 70 long oral presentations and six plenary sessions. The plenary sessions explored six key program domains, including how evidencebased organisations can support the UN Sustainable Development Goals and foster global collaboration through innovative methodological approaches. Discussions emphasised the power of collaboration in evidence synthesis, effective translation and implementation of evidence and advocacy for broader use of evidence in decision-making. Additionally, the Global Evidence Summit highlighted the importance of contextualising global evidence for local impact and measuring its effectiveness in improving lives.











JBI gLOCAL SOLUTION ROOM

The JBI gLocal Solution Room is a series of free events on evidence implementation held for and by practising professionals across the globe.

Hosted by JBI Collaboration Entities in multiple countries and languages, events include webinars, seminars, symposia and workshops, which are designed to help decision-makers and clinicians find pragmatic solutions to the challenges of implementing global evidence in their unique local settings.

From 3–9 June 2024, 37 JBI Collaboration Entities hosted 30 free events worldwide as part of the JBI gLocal Solution Room.

More than 85,000 healthcare professionals, academics, policymakers and researchers attended online or in-person events in 26 cities, towns and villages in 19 countries.







JBI hosted a gLocal Solution Room at SAHMRI on 6 June focusing on enhancing the quality and sustainability of care delivery in pressured systems, supporting patient recovery and wellbeing and fostering evidence-based professional development and teambuilding. The keynote speaker was Associate Professor Karleen Thornton, Academic Lead of Nursing at Flinders University.

WORLD EBHC DAY

World Evidence-Based Healthcare (EBHC) Day is a JBI initiative that was launched in 2020 to raise awareness of the need for better evidence to inform healthcare policy, practice and decision-making to improve health outcomes globally.

The fifth World EBHC Day was launched on 16 July 2024 and held on 20 October 2024.

World EBHC Day is held in partnership by JBI, Cochrane, Campbell Collaboration, CEBHC, Oxford Population Health -AHRU - at the University of Oxford and Institute of Development Studies (IDS).

Representatives from each of the partner organisations comprised the Steering Committee, who were joined by individual members, Laura Boeira (Instituto Veredas) and Hari Sankar (The George Institute for Global Health).

The 2024 campaign, 'Health and Beyond: From Evidence to Action,' addressed the need for greater intersectoral collaboration in the face of the complex global crises affecting health and other sectors. These simultaneous and interconnected crises, or 'polycrisis', threaten the achievement of the United Nations Sustainable Development Goals and the wellbeing of people worldwide.

Connected Conversations

A new initiative in 2024, 'Connected Conversations,' is a videos series comprising three 10-minute videos. Each video addressed one of the three themes relating to the 2024 campaign, Health and Beyond: From Evidence to Action:

Advocates, practitioners, researchers, funders and community members were interviewed for their insights on intersectoral action for health-how people, policy and power should or could be reimagined and how evidence-based approaches can be used to tackle multiple global challenges.



AUSTRALIA AWARDS FELLOWSHIPS

In 2024, JBI partnered with the Department of Foreign Affairs and Trade (DFAT) to deliver Australia Awards Fellowships and workshops for over 60 health researchers, academics, and clinicians. Through the fellowships and workshops, JBI provided education programs aimed at strengthening the healthcare workforce in the Philippines, India, and Papua New Guinea.



Australia Awards are prestigious international scholarships and fellowships funded by the Australian government through the Department of Foreign Affairs and Trade (DFAT). Australia Awards Fellowships aim to build networks of influence and leadership by strengthening partnerships between Australian organisations and partner organisations in the region. Fellowships target senior and mid-career officials and professionals who are in a position to advance development outcomes in priority areas and increase the institutional capacity of partner countries through their leadership.

Health Workforce Development in Evidence Synthesis Fellowship: the Philippines

13 mid-career allied health academics and clinicians commenced the Health Workforce Development in Evidence Synthesis Fellowship in the Philippines through a partnership with Australia Awards, DFAT and JBI.

The program delivered by JBI trains participants to develop, conduct and report robust, high-quality systematic reviews. These systematic reviews aim to provide the strongest possible evidence to inform clinical decision-making and guideline development, supporting the national goal of universal health coverage in the Philippines.

JBI is working closely with the De La Salle Medical and Health Sciences Institute and the Center for Health Research and Movement Science at the University of Santo Tomas in the Philippines. This ensures the program is tailored to local contexts and priorities, while aligning with international best practices through JBI's world-class training in evidence synthesis to inform healthcare policy and practice.







Health Workforce Development in Evidence Implementation Fellowship: India

JBI partnered with DFAT, Australia Awards, Manbhum Ananda Ashram Nityananda Trust (MANT) and the Centre for Public Health Research (CPHR) on a fellowship to help bridge the healthcare gap between tribal and non-tribal communities in West Bengal, India.

The Health Workforce Development in Evidence Implementation Fellowship aims to equip 15 mid-career researchers, policymakers and health practitioners with the knowledge and skills to develop and implement sustainable and culturally appropriate evidencebased healthcare policy and practices.

The program entails JBI working closely with CPHR, which addresses tribal health inequities through evidence-based practice. This ensures the program is tailored to local contexts and priorities while aligning with international best practices through the practical and comprehensive evidence implementation training from JBI.

By focusing on intersectionality, equity and evidence-based health interventions, the fellowship supports healthcare practitioners to design, implement and evaluate culturally appropriate evidencebased policy and healthcare interventions for tribal communities.



Australia Awards: Papua New Guinea Midwifery Graduate Workshop

In April and May 2024, JBI, in partnership with DFAT and the Australia Awards, delivered a specially tailored Clinical Leadership Workshop to 36 graduate midwives in Papua New Guinea.

The tailored version of the JBI Clinical Leadership Workshop addressed the specific knowledge and cultural needs of the Australia Awards participants in New Guinea to build their capacity to actively lead and facilitate evidence-based change within their local communities and health services.

In particular, the workshop equipped participants to become active agents for change and implement evidence-based approaches to improve health outcomes for mothers and newborn children.



JBI SHORT COURSES

Comprehensive Systematic Review Training Program

The Comprehensive Systematic Review Training Program (CSRTP) trains clinicians, policymakers and decision-makers in healthcare how to critically appraise research and report high-quality systematic reviews. This allows participants to provide the strongest possible evidence to inform decision-making or clinical guideline development in healthcare.

In 2024, there was a total of 1,172 registrations for the CSRTP.


